- 2. Minutes for 9/6/2022 & 9/20/2022 (annual meeting) were approved.
- 3. Treasury report for 10/3/2022 was reviewed and approved. Report shows ending balance for FY2021-2022 is \$27,345.33
- 4. It was announced that Rissa Shapiro was suspended for 90 days at the special meeting of the Board convened on 9/26/2022. Upon being notified of her suspension Rissa requested that she be given an opportunity to address the board. Rissa was allowed to address the Board after the regular board meeting tonight.  - c. Purchase bleachers for creek side @ upper courts: \$2k
- 6. The board discussed & agreed that we should have additional social gatherings to promote more involvement from the membership & provide additional opportunities to raise funds for the Club: Bowlero Bowling (\$1.4 k); family outing with live music, hot dogs, burgers, games; low country boil each year in conjunction with tennis tournament (2.5k); cigar night; movie night for kids; Chastain night @ club; Toga party. Kori Tidwell would like to volunteer her help.
- 7. We need to pressure wash Taj, Observation deck & Pavilion and then stain/seal. It was decided to remove the wood deck between the pavilion & courts. The wood picnic tables around the pavilion also need to be replaced.
